## Key Stages of Property Transfer

### 1. Documentation Verification

We conduct thorough due diligence by checking records at:

- **Land Registry** (ConservatÃ³ria do Registo Predial) â€™ Verify ownership and encumbrances
- **Tax Authority** (FinanÃ§as) â€™ Confirm fiscal status and cadastral details
- **Local Municipality** â€™ Validate urban licenses and compliance

### 2. Promissory Contract (CPCV)

- Legally binding agreement securing the transaction
- Typically includes 10-30% deposit
- Establishes completion timeline (usually 30-90 days)
- Specifies conditions for contract termination

### 3. Pre-Deed Requirements

- **IMT Tax Payment:** Calculated based on property value (must be paid before signing)
- **Technical File:** Mandatory for residential properties (DL 68/2004)
- **Energy Certificate:** Required for final deed since 2015 (sellerâ€™s responsibility)
- **Provisional Registration:** Recommended for mortgage financing

## Finalizing the Transaction

### 4. Notarial Deed Execution

- Formal transfer before a notary (required by Art. 875 Civil Code)
- Required documents:
  - Valid IDs of all parties
  - Updated property certificates
  - Proof of IMT and stamp duty payment
  - Mortgage documents (if applicable)

### 5. Post-Deed Obligations

- **Registration:** Must be filed within 60 days at:
  - Land Registry (final ownership registration)
  - Tax Authority (cadastral update)
- **Stamp Duty:** 0.8% of purchase value (paid after deed signing)

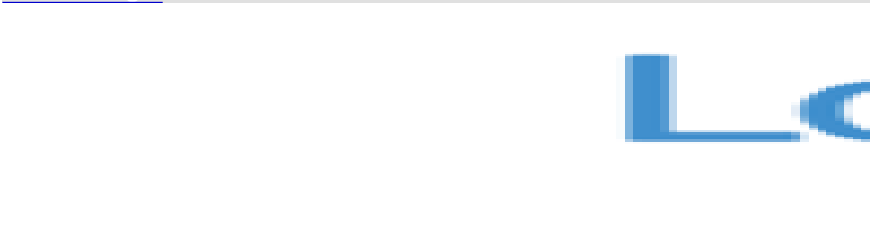

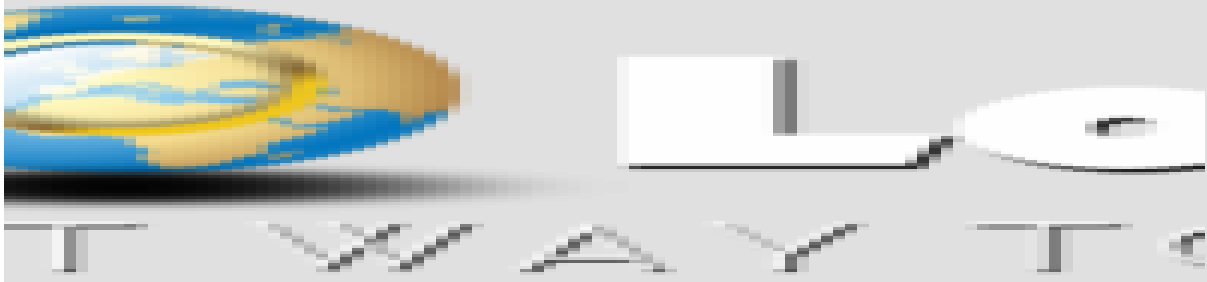
